Re: Disclosure under Regulation 30 of SEBI (LODR) Regulations 2015

This is in response to some misleading reports published in sections of the media, with respect to purported transactions between Gateway Distriparks Ltd ("GDL"), its group companies and its promoters with Infrastructure Leasing & Financial Services Limited ("IL&FS") and/or IL&FS Financial Services Ltd ("IFIN") group entities. It is hereby clarified that neither GDL nor any of its group companies have ever borrowed money from IL&FS and/or IFIN group entities and have not given any loans to nor made any investments in IL&FS and/or IFIN group entities.

Further, neither GDL nor any of its group companies have ever given any loan to Mr. Prem Kishan Gupta ("GDL Promoter") or to any of other companies controlled by him including Prism International Private Limited ("Prism") or to any of the Directors on the board of Prism or any of the companies controlled by them.

As per communication received by GDL from Prism, it has borrowed money from IFIN against a pledge of GDL equity shares held by Prism. Prism further states that it is GDL Promoter's family holding company, a registered NBFC and a Core Investment Company ("CIC"), which is fully compliant with RBI norms. Neither Prism nor any of its subsidiaries have ever given a loan or invested money in IL&FS and/or IFIN group companies.
