Before taking the delivery of the goods.

- **The sale is through e-Auction method.** In case of e-Auction interested buyer can submit their bid through e-Auction only once. Buyers may refer to 'Bidder's Manual' for instructions on bidding process in e-auction- [User's Guide/Manual of e-acution \(for Buyers\)](#).
- MSTC Ltd. shall hereinafter be referred to as **MSTC** and **Gateway Distriparks Limited** as Owner/Seller.
- The sale is through e-Auction method. In case of e-Auction interested buyer can submit their bid through e-Auction only once. Buyers may refer to 'Bidder's Manual' for instructions on bidding process in e-Auction.
- All the offers shall be valid for a period of 60 days from the date of closing of e-Auction. In case bids are not confirmed by Seller within stipulated period, bidders have option to take refund of EMD/Security or may not take the delivery of cargo.
- All the materials are offered for sale on **AS IS WHERE IS AND NO COMPLAINT BASIS**. Material is sold on the assumption that bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complaint shall be entertained in this regard. Goods are sold on the assumption that the bidder has inspected the lots prior to bidding and know what he is bidding for. Buyers have to inspect for hazardous/explosive properties, if any, before submitting the bid. In case they come across any material beyond the scope of the description of material, it should be informed to Seller/MSTC prior to the date of the auction. The material offered for sale can be inspected during 11 AM to 05 PM on the inspection dates as mentioned hereinabove. Where specimen samples are shown it is clearly understood that the quality of the material inside the container/boxes/cartons/bales/cases etc. may not necessarily be of exact quality, quantity, weight, size dimensions, specifications, features etc. Bidders are not allowed to take the sample from the lot unless otherwise specified.
- **Quantities, Quality, sizes, measurements, numbers and weights wherever stated are approximate.** However, the quantity in actual may turn out to be more or less than the estimated quantity. In the event of quantity turning out to be more than the estimated quantity the buyer has to lift the indicated quantity. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this count. In case where the UOM is LOT, the material as offered must be lifted by the buyer on As Is Where Is basis and no excess/short lifting shall be taken onto account.

- The EMD must be @25% of the net sale value quoted (excluding GST and duties) against each lot. Upon receipt of EMD within the time prescribed by the Seller, a detail of such payments shall be provided to MSTC and Sale Order/ Acceptance Letter will be issued by MSTC. Upon issue of sale order the EMD shall automatically be converted into security deposit. The Security Deposit as specified in Sale order shall be adjusted only at the time of final payment. Non-payment of EMD within the stipulated time would lead to deactivation of the buyer login for 6 months. The Contract shall be treated as having been entered into as soon as the ink-signed Sale Order/Acceptance Letter is issued by MSTC on

- **FINAL PAYMENT:** The Purchaser shall pay balance of the purchase price within ten (10) working days from the date of issue of sale order. The payment will be made in two parts: (i) to MSTC for (2.655% -TDS) + 1% IT TDS and (ii) to Seller for the remaining amount. For any delay in making payment within the time limit specified, the due payment may be made together with late penalty @ 1% per week or part thereof on the Sale Value for the period of delay within 14 days from the due date and thereafter on the sole discretion of the Seller only. Seller or MSTC in consultation with SELLER reserves the right not to accept the payment with or without the late penalty after expiry of the above mentioned time limits or even within the aforesaid additional period of 14 days, at Principal/MSTC's (in consultation with principal) sole discretion and in such an event the sale of the lot will be automatically cancelled and the Earnest Money/Security Deposit (as the case may be) will automatically stand forfeited. **In case the Lot is approved and the EMD has not been deposited, then full amount may be deposited in 7+10 days. No further extension is granted.**
- **STATUTORY PAYMENTS:** The rate of Excise Duty, Sales Tax/VAT Income Tax, Education Cess or any other statutory Duty / Tax / Levy / Charge etc. will be applicable and payable by the Buyer as prevailing on the date of actual physical delivery of materials. The rates of Duties and Taxes displayed on the e-Auction Website are only indicative and based on the rates prevailing before the commencement of the e-Auction.
- On receipt of full payment by SELLER and service charge by M/s MSTC Ltd, delivery order shall be issued by M/s MSTC Ltd. with a copy to the seller and the buyer.
- In case the date of submission of payment happens to fall on a Public Holiday, the next day shall be considered as the date of submission of payment. DDs of Cooperative Bank shall not be accepted and will be returned without any action being taken on them.
- Payment towards material value and other dues is to be made as stipulated in Sale Order/Acceptance letter. SELLER will re-auction the lot accordingly.
- **LATE PAYMENT PENALTY:** For Any delay in making payment within time limit specified, the due payment may be made together with late payment penalty @ 1% per week or part thereof on the entire bid value, maximum up to 14 days (calculated from the next day of last date of payment submission by bidder). In case the bidder does not submit the payment in time or in extended time of 14 days with penalty, sale of the concern lot will be automatically cancelled and the Earnest Money/Security Deposit (as the case may be) will automatically stand forfeited. Such late payment penalty along with balance payment is to be submitted to SELLER directly either through on line or through bank draft.
- **DELIVERY PERIOD:** The successful bidders shall lift the cargo allotted to them by **Gateway Distriparks Limited** labour and transport has to be arranged at their own cost. Delivery is to be taken within 3 Days (Three Days) from the date of Release Order issued by the Seller (on behalf of the Delivery Order issued by MSTC) including date of issuance of Release Order. On the basis of the Release Order, SELLER will issue gate pass for the particular lot. If last day of delivery falls on a public holiday, the next working day shall be considered as the last date of lifting.
- **DEFAULT IN LIFTING:** In case of any default in lifting of materials by the Buyer

within the prescribed free time limit, the outstanding material may be lifted subject to payment of Ground Rent by the Buyer directly to the SELLER for the period of delay up to 2 weeks maximum, provided written request is received before the expiry of the free lifting period. All matters relating to charging of Ground Rate will be decided by the In case of Goods sold on Lot Basis, the Ground Rent will be calculated on the value of the entire Lot even if lifted in part, where as in case of Goods sold on Unit Weight or Unit Number Basis, the Ground Rent will be calculated on the value of unlifted quantity. However, it must be noted by the Bidders that it will be the sole discretion of the SELLER not to allow the Buyer to lift the Goods with or without the Ground Rent after the expiry of the stipulated free Delivery period and in such event, the sale of the material not lifted by the Buyer(s) will be automatically cancelled and SD/amount equivalent to SD of the lot will be automatically forfeited. Pursuant to issuance of CBIC Notification No. 25/2024-Central Tax dated 09.10.2024, it may be noted that necessary compliance for the payment relating to Tax Deduction at Source under Section 51 of the CGST Act, 2017 on metal scrap, wherever applicable, is to be dealt directly by the Buyer with Seller. TDS at the rate of 2% under GST is applicable only when seller and buyer are both registered under GST as regular taxpayer.
