### GST may Improve Compliance, Raise Tax Receipts: Moody's

New Delhi: Moody's has said that Rajya Sabha's approval to the constitutional amendment bill paves the way for the implementation of the GST, and is a positive development for India's credit rating. "The GST will have a positive impact on growth and tax revenues over the medium term, supporting the sovereign's credit profile," Moody's said.

"It will remove a key hurdle to the smooth movement of goods and services, and by reducing the tax administration costs of the government and corporates, it will improve compliance and raise tax receipts," Moody's said in a report titled 'India Credit, Upper House Passage Paves Way for GST Bill Implementation, a Credit Positive'.

The agency said there won't be a short-term impact as effective implementation will take some time
