दिसते. अपघातांमुळे होणारी जीवितहानी व वित्तहानी हे तर प्रश्न आहेतच; परंतु नियमांना वळसा घालण्याच्या प्रवृत्तीमुळे वाहतूक कोंडी, त्यातून मनुष्यबळाचा अपव्यय, प्रदूषण व त्यातून उद्भवणाऱ्या आरोग्यविषयक समस्या असे अनेक प्रश्न निर्माण होतात. सुरक्षिततेच्या व आधुनिकतेच्या, तंत्रज्ञानाच्या दृष्टिकोनातून आमूलाग्र बदल घडविण्याचा उद्देश या सुधारणांमधून दिसून येतो. वाहनांच्या विम्याबाबतच्या तरतुदी सुलभ करण्यात आल्या आहेत. याशिवाय शिकाऊ परवाना ऑनलाईन सुविधा निर्माण करणे, परवाना नूतनीकरण तसेच त्याचा कालावधी वाढविणे, शिक्षेच्या तरतुदी कडक करणे हीदेखील नव्या तरतुदीची वैशिष्ट्ये आहेत. सर्वांत महत्त्वाचे म्हणजे अंतर्गत भागापर्यंत पोचणारी, ग्रामीण भागापर्यंत पोचू शकेल अशी सार्वजनिक वाहतूक व्यवस्था निर्माण होण्यास चालना देण्याचा प्रयत्नही नव्या तरतुदीत दिसतो. रस्त्यावरील अपघात कमी व्हावेत, अपघातग्रस्तांना तातडीने मदत मिळावी, त्यांना भरघोस नुकसानभरपाई मिळावी, असे विशेष प्रयत्न या सुधारणांमध्ये दिसून येतात. तंत्रज्ञानाचा मोठ्या प्रमाणात वापर व


शुल्क राज्य सरकार निश्चित करते. या तडजोड शुल्कामध्ये कमी-जास्त करण्याचा अधिकार यंत्रणांना नसतो. या तडजोड शुल्कामध्ये आता मोठ्या प्रमाणात वाढ होईल. या तडजोड शुल्काबरोबर राज्य सरकारने ठरविल्यास नियमभंग करणाऱ्या व्यक्तीला काही काळ समाजसेवा करण्याचे बंधन यंत्रणा घालू शकेल. धोकादायक पद्धतीने वाहन चालविणाऱ्यांसाठी कठोर शिक्षा, हेही बदलाचे एक वैशिष्ट्य आहे. अशा नियमभंगाबाबत सहा महिने किंवा एक वर्षापर्यंत तुरुंगवास किंवा एक हजार किंवा पाच हजार रुपयांपर्यंत दंड किंवा दोन्ही अशी शिक्षा होऊ शकेल. धोकादायक पद्धतीने वाहन चालविणे म्हणजे सिग्नल तोडणे, थांबण्याच्या चिन्हाचे उल्लंघन, वाहन चालविताना मोबाईलचा वापर, पुढील वाहनांना चुकीच्या पद्धतीने ओलांडणे किंवा विरुद्ध बाजूने वाहन चालविणे या कृतींचा समावेश करण्यात आला आहे. अल्पवयीनांच्या नियमभंगाबद्दल पालकांना जबाबदार धरले जाईल. काटेकोर अंमलबजावणी, तसेच सर्व यंत्रणांमध्ये समन्वय व सहकार्य निर्माण होईल, तेव्हाच मोटार वाहन कायद्यातील या सुधारणांचा चांगला परिणाम दिसेल.

‘शून्य प्रहर’ ऐवजी ‘मुक्त चर्चाकाळ’

‘स्वा’ तंत्र्याचा अमृतमहोत्सव नव्या संसदेत- ‘झिरो अवर’ शब्दही इतिहास जमा होणार? ही बातमी वाचली. ‘झिरो अवर’ हे नाव ऐकायला चांगले वाटत नाही, त्याऐवजी एखादे नवे नाव सुचवावे, असे राज्यसभेचे अध्यक्ष व्यंकय्या नायडू यांनी म्हटले आहे. संसदेत प्रश्नोत्तरांच्या तासानंतर दिनक्रमामध्ये न नमूद केलेल्या विषयांवरील चर्चा दुपारी बारा ते एक या दरम्यान चालण्याची प्रथा पडली. यालाच ‘झिरो अवर’ किंवा मराठीत ‘शून्य प्रहर’ अशी ओळख मिळाली. मुळात a.m. ante (before) meridiem (midday), p.m. post meridiem हे शब्द लॅटिन भाषेतून आलेले आहेत. मराठीमध्ये पूर्वमध्यान्ह आणि मध्यानंतर असे म्हणता येईल. ‘झिरो अवर’ दुपारी बारा वाजता सुरू होतो. यामुळे ‘झिरो अवर’ऐवजी आता ‘मेरिडियन अवर’ हा शब्द योग्य वाटतो. मराठीमध्ये ‘मध्य प्रहर’ असे म्हणता येईल. काही जण मेरिडियनऐवजी मेरिडियन (Meridian) हा इंग्रजी शब्द वापरताना दिसतात. कारण या शब्दाचा अर्थ कोणत्याही भाषेत उच्चांक, शिखर, कळस, रेखावृत्त या अर्थी येतो. म्हणजे शिखर बिंदूच्या अलीकडील आणि पलीकडील काळ असे ते मानतात. मात्र या ठिकाणी हा शब्द सलग म्हणजे ‘antemeridian’ असा लिहावयास हवा, असे काही तज्ज्ञांचे मत आहे. समजा या दोन शब्दांवरून वाद झाला आणि बहुसंख्य व्यक्तींनी ‘मेरिडियन’ हा शब्दच स्वीकारला, तर ‘मेरिडियन अवर’ आणि मराठीत ‘शिखर प्रहर’ असे म्हणावे. पुढे जाऊन असे सुचवावे वाटते, की हा मुक्त चर्चेचा (चर्चा-परिचर्चा, विचारविमर्श) तास असल्याने ‘ओपन डिस्कशन अवर’ (ओडीएच) मराठीत ‘मुक्त चर्चा काळ’ असेदेखील म्हणण्यास हरकत नाही. इंग्रजीत १२ a.m., १२ p.m. असे लिहिणे योग्य वाटत नाही. कारण ही अचूक वेळ पूर्वमध्यान्ह आणि मध्यानंतरचीदेखील नाही.
