इतिहासकार आणि सामाजिक चिंतक

भारतातील प्रख्यात मार्क्सवादी इतिहासकार, विचारवंत आणि सामाजिक चिंतक के. एन. पणिकर यांचे शिरुअनंतपुरम येथे निधन झाले. त्यांच्या निधनामुळे भारतीय इतिहासलेखन क्षेत्रातील एक महत्त्वपूर्ण आणि प्रखर बौद्धिक आवाज कायमचा शांत झाला आहे.

संशोधन सुरू केले आणि पुढे ते भारतातील प्रमुख मार्क्सवादी इतिहासकार म्हणून ओळखले जाऊ लागले. त्यांच्या संशोधनाचा मुख्य केंद्रबिंदू औपनिवेशिक भारतातील सामाजिक चळवळी, राष्ट्रवाद, धर्म आणि संस्कृतीचे राजकारण, तसेच समाजातील वंचित घटकांचे इतिहासातील स्थान हा होता. त्यांनी इतिहास केवळ राजे-महाराजे किंवा राजकीय घटनांचा आलेख नसून तो समाजातील संघर्ष, परिवर्तन आणि लोकचळवळींचा दस्तावेज आहे, ही भूमिका सातत्याने मांडली.

पणिकर यांनी दीर्घकाळ 'जेएनयू'मध्ये इतिहासाचे प्राध्यापक म्हणून कार्य केले. 'जेएनयू'तील त्यांच्या अध्यापनामुळे अनेक पिढ्यांतील विद्यार्थ्यांवर आणि संशोधकांवर मोठा प्रभाव पडला. ते विद्यार्थ्यांना केवळ

घटनांची माहिती देणारे शिक्षक नव्हते; तर इतिहासाकडे चिकित्सक आणि वैज्ञानिक दृष्टीने पाहण्याची प्रेरणा देणारे मार्गदर्शक होते. पुढे त्यांनी केरळमधील 'केरळा काउन्सिल फॉर हिस्टोरिकल रिसर्च' या महत्त्वाच्या संशोधन संस्थेचे संस्थापक अध्यक्ष म्हणूनही काम केले. या संस्थेमार्फत त्यांनी केरळच्या सामाजिक इतिहासाचा सखोल अभ्यास घडवून आणला आणि इतिहास संशोधनाला नवे आयाम दिले.

भारतीय इतिहासलेखनात धर्मनिरपेक्षता आणि सांप्रदायिकतेच्या प्रश्नांवर गंभीर बौद्धिक चर्चा घडवून आणण्यात पणिकर यांचे योगदान महत्त्वाचे मानले जाते. त्यांनी वारंवार असे अधोरेखित केले, की इतिहासाचा वापर राजकीय हेतूंनी वाकवला जाऊ नये. त्यांच्या मते इतिहासाचा अभ्यास वैज्ञानिक पद्धतीने, पुराव्यांच्या आधारे आणि सामाजिक वास्तव लक्षात घेऊन केला पाहिजे. त्यांनी भारतातील सांप्रदायिक राजकारण, धार्मिक ध्रुवीकरण आणि इतिहासाच्या राजकीय वापरावर कठोर टीका केली. त्याचबरोबर त्यांनी दलित, आदिवासी आणि इतर वंचित समाजघटकांच्या चळवळींचे महत्त्व अधोरेखित करत इतिहासलेखन अधिक समावेशक करण्याचा प्रयत्न केला.

पणिकर यांनी अनेक पुस्तके, संशोधन निबंध आणि व्याख्याने यांद्वारे भारतीय समाजातील परिवर्तनाच्या प्रक्रियेचे सखोल विश्लेषण केले. त्यांच्या लेखनात मार्क्सवादी दृष्टिकोन स्पष्ट

दिसून येतो; मात्र तो संकुचित विचारसरणीपुरता मर्यादित नसून सामाजिक वास्तवाचे विश्लेषण करणारा व्यापक बौद्धिक दृष्टिकोन होता. त्यांनी इतिहास, संस्कृती आणि राजकारण यांच्यातील गुंतागुंतीचे संबंध उलगडून दाखवले. त्यामुळेच भारतीय इतिहासशास्त्रात त्यांचे स्थान अत्यंत महत्त्वाचे मानले जाते. त्यांच्या कार्याची दखल घेत 'केरळ साहित्य अकादमी'ने २०१७ मध्ये त्यांना मानद सदस्यत्व प्रदान केले होते. त्यांच्या वैयक्तिक आयुष्याबद्दल बोलायचे झाले तर ते अत्यंत साधे आणि विचारप्रधान जीवन जगणारे व्यक्तिमत्त्व होते. त्यांची पत्नी उषा भागवंत या राजस्थान विद्यापीठातील त्यांच्या सहाय्याची होत्या. आपल्या कुटुंबासोबत त्यांनी शांत आणि बौद्धिक वातावरणात आयुष्य व्यतीत केले. त्यांच्या सहकाऱ्यांच्या मते ते अत्यंत सौम्य, नम्र आणि विद्यार्थ्यांशी आत्मोपायने निरंतर साधणारे शिक्षक होते. इतिहासाच्या माध्यमातून समाजातील अन्याय, विषमता आणि सांप्रदायिकतेविरुद्ध आवाज उठवणारा एक प्रखर बुद्धिवादी विचारवंत म्हणून के. एन. पणिकर यांची ओळख कायम राहिल. त्यांच्या लेखनाने आणि विचारांनी भारतीय इतिहास अभ्यासाला एक चिकित्सक आणि लोकाभिमुख दिशा दिली. त्यामुळेच त्यांच्या निधनाने भारतीय बौद्धिक विश्वात एक मोठी पोकळी निर्माण झाली आहे.

मुंबई, ता. १० : केंद्रीय अन्वेषण विभागाने (सीबीआय) मध्य रेल्वेतील मुख्य विद्युत वितरण अभियंतापदावर कार्यरत असलेल्या अधिकाऱ्याला लाच घेताना अटक केली. या कारवाईत दोन खासगी व्यक्तींनाही अटक करण्यात आली आहे. तपासादरम्यान सुमारे १.४७ कोटी रुपयांची रोख रक्कम, सोन्या-चांदीचे दागिने आणि गुंतवणुकीची कागदपत्रे जप्त करण्यात आली आहेत.

माहितीनुसार, भारतीय रेल्वे विद्युत अभियांत्रिकी सेवा २००३ बॅंचचे अधिकारी रमेश कुमार चौबे हे मध्य रेल्वेत मुख्य विद्युत वितरण अभियंता पदावर कार्यरत होते. सुमारे ४०.५४ कोटी रुपयांच्या निविदा प्रक्रियेत अनियमितता केल्याचा आरोप त्यांच्यावर आहे. संबंधित निविदा आहे खासगी कंपनीला देताना संयमित करून ४० लाख रुपयांची लाच मागितल्याचा आरोप सीबीआयने केला आहे. ही रक्कम निविदेच्या एकूण किमतीच्या सुमारे एक टक्के असल्याचे सांगितले जाते.
