Greetings!

This is to inform you that in line with Customs Notification No. 6/2016 dated 29/8/2016, ICD Gateway Rail Freight Limited – Sahnewal (Ludhiana) would be assigned with a new Customs Location Code- INSGF6 w.e.f. 03rd Oct 2016, a copy of customs Public notice is attached for your ready reference.

Therefore, all imports landing at ports on and after 3rd Oct'16 may please be filed for our new Customs Location Code- INSGF6 while filing of IGM and SMTP at ports. We have requested Customs for allowing a general permission for clearance of the containers lying at ICD GRFL, in transit, lying or under discharge at port as on 3rd Oct'16 for which IGM/SMTP has already been filed with the current code of GRFL, Sahnewal. Customs have conveyed to grant a general permission for import clearance at ICD GRFL, Sahnewal for all such containers. Customs have conveyed to grant a general permission for export clearance at ICD GRFL, Sahnewal on both the codes (existing code and new code) during transition period.

It is important to mention here that all other details of ours i.e. carrier code, Carrier Bond details, port code, etc. would remain same for shipments destined for ICD GRFL -Sahnewal, Ludhiana.

The important information/codes for filing IGM and SMTP for ICD GRFL, Sahnewal, wef 03rd Oct 2016, are as per below table for your ready reference. The only change is in Custom Code rest all details are as existing only.
