Dear Valued Customer,

Greetings from Gateway Rail!

This is to inform you that in line with Customs Notification No. 6/2016 dated 29/8/2016, ICD Gateway Rail Freight Limited – Sahnewal (Ludhiana) would be assigned with a new Customs Location Code- INSGF6 w.e.f. 03rd Oct 2016, a copy of customs Public notice is attached for your ready reference.

Therefore, you are advised to file Shipping Bill of all your export consignments for our new Customs Code- <u>INSGF6</u> from 3rd Oct'16 onwards. It is important to mention here, that you would need to register your AD Code and other relevant details with ICEGATE for the purpose. Dedicated help desks would be provided by Customs at ICD GRFL, Sahnewal for the benefit of trade during transition period.

Steps to be taken to ensure shipping bill filing for new customs code INSGF6 are as given below:

- 1. AD Code registration with our new location code
- 2. Self-Sealing permission for our new location code
- 3. IFSC Code registration for our new location code
- 4. Any other specific **export incentive**/ **scheme** being availed by you to be registered under new location code.

Customs have conveyed to grant a general permission for export clearance at ICD GRFL, Sahnewal on both the codes (existing code and new code) during transition period. However, we are hopeful that we would be able to complete the migration to new code smoothly, with all your support.

All the existing trade facilities being offered by Customs at ICD GRFL, Sahnewal would continue to be offered. Similarly, we would continue to offer all related services by GRFL and the only change is of Location code.

In view of the above, you are requested to file shipping bills of all your export shipments for our new customs Code <u>INSGF6</u> from 03 Oct 2016 onwards.

For our Customers who bring their export containers for Rail out to ports through ICD GRFL - Sahnewal, after custom clearance at other locations (including any other custom location ICDs/CFSs of Ludhiana, Punjab and Himachal Pradesh) may continue to do so as we have all the arrangements in place for same without any change and we would be happy to connect your consignments to the ports as per existing procedure with best of service levels.
