Greetings from GatewayRail,

As per the directive of Government of India, "Goods & Service Tax" (GST) is expected to be implemented from 1<sup>st</sup> July 2017. As per the proposed GST regime, capturing of GSTN details in the invoice and electronic cash ledger is very important as input credit will be available only if all these details are correctly captured.

As per Section 16 CGST Act, the Input Tax Credit for the Tax charged on any supply of goods or services or both which are used or intended to be used in the course of furtherance of business will only be admissible if the same are credited to the electronic credit ledger of the person receiving such goods or services. Further, it provides that such supply of goods or services has to be evidenced by a tax invoice or debit note issued by the supplier registered under the CGST Act.

If you have a <u>single location</u> of business, we request you to provide your GST Credentials specifying the registration number and address to update the same in our records.

If, you have <u>multiple locations</u> of business and receive services from our terminals / offices spread across different states, we would request you to specify the address and GST number at which the Invoices will be raised from our different terminals / offices.

You are requested for a timely update of any changes or modifications of these details.
