NOTES:

1. GST as applicable from time to time will be charged extra except 7(a) item.
2. The charges for the shipment must be paid by way of CHQ's / DD / Bank remittance only and no cash transactions are accepted. In case of default the CFS can exercise lien on Cargoes of the CHA concerned.
3. For movement of Export Containers to Terminal, the CFS must be given minimum 72 hours' time after completion of entire stuffing / complying all necessary Customs formalities & issuance of F – 13 by the shipping lines etc., CFS's are not liable to pay any shut out, direct loading and storage charges levied by VCTPL.
4. The insurance of cargo is required to be taken by the consignor/consignee from warehouse to warehouse. The liability of Gateway Distriparks Limited, as the Customs Cargo Service Provider is limited to the liabilities arising out of its role as Customs Cargo Service Provider as per the legal framework in this regards.
5. For lot of 10 containers and above CFS requires sufficient time for DE stuffing, particularly for Bulk & Machinery cargoes.
6. All CHA's are required to inform well in advance regarding nature of cargo being handled at CFS like scrap and other bulk charges.
7. CTC or any other Charges from Terminal / Shipping line will not be on account of CFS.
8. Cheque's / DD / Bank remittance - to be made in favour of " Gateway Distriparks Limited "
